ORDER TO CEASE AND DESIST ACTIVITIES AND NOTICE OF APPEAL RIGHTS

ORDER TO CEASE AND DESIST ACTIVITIES AND NOTICE OF APPEAL RIGHTS

Nevada, Department of Business and Industry, Financial Institutions Division (hereinafter "Division") hereby orders PROCESSING SERVICE CENTER, LLC, (hereafter "RESPONDENT") to cease and desist from any and all activities which covered under Nevada Revised Statutes (NRS) Chapter 671.

JURISDICTION

- 1. The business of money transmission in the State of Nevada is governed by chapter 671 of the Nevada Revised Statutes (NRS) and chapter 671 of the Nevada Administrative Code (NAC). The Division has primary jurisdiction for the licensing and regulation of persons operating and/or engaging in money transmission services. See generally NRS 671.050.
- 2. Pursuant to the authority vested by NRS chapter 671, the Division hereby makes the following Findings of Fact, Conclusions of Law, and Order.

FINDINGS OF FACT

1. Respondent PROCESSING SERVICE CENTER, LLC, is a Nevada Limited Liability Company and is registered as a Limited Liability Company under the laws of the

State of Nevada and may be served through its resident agent Paula Engelbrecht, 1291 Galleria Drive, Ste. 125, Henderson, NV 89014.

- 2. Respondent is engaged in the business of money transmittal at a place of business located at 1291 Galleria Dr., Suite 125, Henderson, NV 89014.
 - 3. Respondent is not a licensed money transmitter in the State of Nevada.
- 4. Respondent is not a licensed agent for a money transmitter in the State of Nevada.
- 5. During the examination of licensee North American Asset Services, LLC, the Division discovered that it had a contract with Respondent to receive and transmit money.
- 6. In the contract, North American Asset will refer consumers to Respondent "to process ACH and credit card transactions offered by consumers as payment on delinquent accounts."
- 7. Specifically, Respondent will "accept payments, in compliance with all applicable laws and regulations, all Referred Accounts and use its best efforts to obtain all amounts due."
- 8. As part of the contract, Respondent is required to comply with "all applicable federal, state and local laws, rules and regulations."
- 9. Pursuant to this contract, Respondent received money from consumers and transmitted payment to North American Asset Services.
- 10. Respondent received \$9.95 for every transaction processed for North American Asset Services.
- 11. Any finding of fact which is more properly characterized as a conclusion of law shall be construed as such.

CONCLUSIONS OF LAW

1. NRS 671.040 reads as follows:

NRS 671.040 License required. 1. A person shall not engage in the business of selling or issuing checks or of receiving for transmission or transmitting money or credits unless the personis licensed pursuant to this chapter. 2. A person shall not engage in

such business as an agent except as an agent of a licensee or a payee.

- 2. NAC 671.070(1) states that a person may not engage in "the business of selling or issuing checks or of receiving for the transmission or transmitting money or credits" without first obtaining a "license, certificate and permit."
- 3. NRS 671.090 states that a person can only act as an agent to a licensee and that a license would be required for the agent if the agent "sells or delivers the licensee's checks over the counter to the public...."
 - NAC 671.085 reads as follows:

NAC 671.085 Administrative fines and orders to cease and desist. (NRS 671.030, 671.185)

- 1. If a person engages in an activity in violation of the provisions of this chapter or chapter 671 of NRS, the Commissioner may issue an order to the person imposing an administrative fine pursuant to NRS 671.185 and directing the person to cease and desist from engaging in the activity.
 - 2. An order issued pursuant to subsection 1 must:

(a) Be in writing.

- (b) Be served by certified mail on the person to whom the order is directed. For the purposes of this paragraph, proof of attempted service by certified mail to the last known address of the person is sufficient to establish that service was complete.
- (c) State that the person has 30 days after the date of the order to request an administrative hearing and that the order shall be deemed final if the Division does not receive a verified petition for a hearing within the prescribed time.
- (d) State that, in the opinion of the Commissioner, the person has engaged in an activity:
- (1) For which the person has not received a license as required by chapter 671 of NRS; or
- (2) In a manner that violates the provisions of this chapter or chapter 671 of NRS.
- 3. A person who is served with an order to cease and desist pursuant to this section shall not engage in any activity prohibited by the order after the person is served with the order unless the order is suspended or rescinded.
- 4. If a verified petition for a hearing is received by the Division within the prescribed time, the Commissioner or the designee of the Commissioner shall hold a contested hearing.
- 5. An order to cease and desist may be amended or rescinded at any time before or during the contested hearing. Subject to the discretion of the Commissioner or the designee of the

Commissioner, the hearing may be continued if an amendment to the order materially alters the facts or legal issues relating to the order or the respondent demonstrates an inability to prepare for the hearing as a result of the amendment.

- 6. The decision of the Commissioner or the designee of the Commissioner is final for the purposes of judicial review.
- 5. NRS 671.185 (1) states that "the Commissioner may impose an administrative fine of not more than \$10,000 upon a person who ... without a license conducts any business or activity for which a license is required pursuant to the provisions of this chapter."
- 6. Similarly, a violation of any provision of NRS chapter 671 or any regulation adopted pursuant thereto is subject to a fine of not more than \$10,000.00.
- 7. Respondent violated NRS 671.040, by engaging in the business of "receiving money for transmission or transmitting money or credit" without a valid license.
- 8. Based on the foregoing violations, the Commissioner is authorized to enjoin activity which is in violation of NRS chapter 671.
- Any conclusion of law which is more properly characterized as a finding of fact shall be construed as such.

ORDER

IT IS HEREBY ORDERED that Respondent PROCESSING SERVICE CENTER, LLC, shall **CEASE AND DESIST** from operating and/or engaging in the business of "selling or issuing checks or of receiving for transmission or transmitting money or credits" within the State of Nevada unless and until such time as RESPONDENT has become licensed by the Division pursuant to NRS chapter 671.

IT IS FURTHER ORDERED that Respondent shall **CEASE AND DESIST** from any and all participation as an agent for any other money transfer company engaged in the business of "selling or issuing checks or of receiving for transmission or transmitting money or credits" within the State of Nevada unless and until such time as RESPONDENT has become licensed by the Division pursuant to NRS chapter 671.
