Pursuant to NRS 604C.640, and section 20 of the approved Regulations for this chapter, a licensee shall submit a report to the Commissioner that includes the following:

- The number of consumer litigation funding transactions in which the company engaged in this State for the immediately preceding year;
- A summation of the total funded amount of the consumer litigation funding transactions in which the company engaged in this State for the immediately preceding year, expressed in dollars;
- The annual percentage charged to each consumer when repayment was made; and
- A list of all consumer funding transactions for the immediately preceding year, which should include:
  - o The name of the consumer;
  - o The funded amount for each consumer; and
  - o A detail of all charges and the document preparation fee charged to each consumer.
