The Nevada Financial Institutions Division (NFID) is planning to promulgate regulations in support of Senate Bill 276 (SB276) governing Collection Agencies and Debt Buyers under NRS Chapter 649. The first step is for NFID to receive input from small businesses regarding the adverse and beneficial impacts the proposed regulations may have on those small businesses. NFID will then hold a workshop(s) in the near future to continue the rulemaking process.

The subjects for the proposed regulatory language are as follows:

1. Update current regulation due to the changes SB276 made to NAC 649.
2. Update licensing fees.
3. Clarify the applicability of certain statutory provisions.
4. Provide other matters properly relating to the regulation of SB276.

2. Consider methods to reduce the impact of the proposed regulations; and
3. Prepare a small impact statement and make copies of the statement available to the public at the workshop conducted and the public hearing held pursuant to Nevada Revised Statutes (NRS) 233B.061.
