

Governor's Executive Order 2023-003  
Small Business Impact Questionnaire  
(Response Requested by September 18, 2023)

The Nevada Financial Institutions Division (NFID) is planning to promulgate regulations in support of Governor's Executive Order 2023-003. The first step is for NFID to receive input from small businesses regarding the adverse and beneficial impacts the proposed regulations may have on those small businesses. NFID will then hold a workshop(s) in the near future to continue the rulemaking process.

The proposed regulatory language changes the following chapters:

1. NAC 628B- Removing one section.
2. NAC 662 – Changing “Administrator” to “Commissioner” in several sections.
3. NAC 676A- Revising one section and removing three sections.
4. NAC 677- Removing three sections.
5. NAC 678- Removing one section and changing the whole chapter from “678” to “672” to align with the NRS change from 678 to 672.

The following questions pertain to how the new language to the Nevada Administrative Code will affect your business. If it is determined that the proposed regulatory language is likely to impose a direct and significant economic burden upon a small business, or directly restrict the formation, operation or expansion of a small business, the Financial Institutions Division can take any of the following actions:

1. Insofar as practicable, consult with owners and officers of affected small businesses;
2. Consider methods to reduce the impact of the proposed regulations; and
3. Prepare a small impact statement and make copies of the statement available to the public at the workshop conducted and the public hearing held pursuant to Nevada Revised Statutes (NRS) 233B.061.
